Official Rules

Sweepstakes for 2017 Travel

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT IMPROVE YOUR CHANCES OF WINNING.

The Quo Student Travel Bring Your Bestie Referral Sweepstakes (the “Sweepstakes”) may only be entered in or from the fifty (50) United States and the District of Columbia. Entries originating from any other jurisdiction are not eligible for entry. This Sweepstakes is governed exclusively by the laws of the United States.

1. How to Enter. By submitting an entry, each entrant agrees to the Official Rules and warrants that his or her entry complies with all requirements set out in the Official Rules. This is not a skill-based Sweepstakes, and chance does play a part in the determination of the winner. To enter the Sweepstakes, submit the name and contact information as a referral and invite them to travel with Quo. For every referral who then enrolls in travel you will receive “thank you” swag from Quo. In addition, for each referral enrollment made by December 31, 2016 you’ll receive 2 entries into the \$500 travel credit drawing. For each referral enrollment made between January 1 and February 14, 2017 you’ll receive 1 entry into the \$500 travel credit drawing. Submissions can be made from December 1, 2016 through February 14, 2017 at 11:59 PM Pacific Time (PT) (the “Sweepstakes Period”). All submissions shall be collectively referred to herein as the “Submissions” or each as a “Submission.”

2. Submission Requirements. The following submission requirements must be followed in order to enter this Sweepstakes. i. The Submission must be in a digital format; ii. you must complete all required fields of the referral registration form. There are no limits to how many referrals you submit.

3. Start / End Dates. Sweepstakes begins at 12:00 PT on December 1, 2016, and ends at 11:59 PM PT on February 14, 2017 (the “Sweepstakes Period”).

4. Eligibility. Only open to legal residents of the 50 United States and the District of Columbia, who are, at the time of entry, 13 years of age or older and full-time student in grades 5 through 12 in good standing at any public, private, or parochial school or who are home-schooled. Entrants below 13 years of age may be required to provide written consent of a parent or legal guardian prior to entry. Void where prohibited, taxed, or restricted by law. Employees, officers, and directors of Sponsor and its affiliates, its advertising and promotional agencies, its judging organization, manufacturers, or distributors of Sweepstakes materials and their immediate families (parents, children, and spouses) are not eligible. All federal, state, and local laws and regulations apply. This Sweepstakes is intended for



viewing in the United States only and shall only be construed and evaluated according to United States law. Entrants are not authorized to participate in the Sweepstakes if entrants are not located within the fifty (50) United States and the District of Columbia. Entrants fully and unconditionally agree to be bound by these Official Rules and the decisions of Sponsor, which are final in all matters relating to this Sweepstakes. No limit to Submissions per entrant.

5. Winner Determination. The Prize winner will be determined in a random drawing from among all valid entries. Drawing will be held on February 15, 2017 by representatives of Sponsor, whose decisions are final on all matters relating to this Sweepstakes. Odds of winning are determined by the number of eligible entries received in total. i. Grand Prize. Subject to verification and compliance with these Official Rules, one (1) grand prize winner will be selected at random in accordance with the Judging Criteria.

6. Prize Details. One (1) grand prize will be awarded and will consist of a \$500 travel credit toward summer 2017 travel with Quo Student Travel (\$500 USD approximate retail value). The Prize will be awarded to the entrant or his/her parent/legal guardian if the entrant is a minor in his/her state of residence. Winner, or his/her parent/legal guardian if he/she is a minor, must agree to be bound by these Official Rules as a condition to being awarded the Prize. Prize does not include federal, state, and local taxes, which shall be the winner's sole responsibility. Prize cannot be transferred, assigned, substituted, or redeemed for cash except at Sponsor's sole discretion. Sponsor reserves the right to substitute the Prize or any portion thereof with a prize of equal or greater value. Sponsor will not replace any lost, mutilated, or stolen prizes.

7. Notification. Winner will be chosen on or about February 15, 2017, and announced via the Quo Student Travel Facebook page. Winner may be required to sign and return an Affidavit of Eligibility and Liability/Publicity Release within seven (7) calendar days of prize notification. If winner cannot be contacted within seven (7) calendar days of first notification attempt, winner fails to return the Affidavit of Eligibility and Liability/Publicity Release as specified above, if prize or prize notification is returned as undeliverable, if winner rejects his/her prize, or in the event of noncompliance with these Sweepstakes Official Rules and requirements, such prize will be forfeited, and an alternate winner may be selected from all remaining eligible entries. Upon prize forfeiture, no compensation will be given. Once winner has signed and returned the Affidavit of Eligibility and Liability/Publicity Release and his/her eligibility has been confirmed, Prize will be delivered. Allow 6-8 weeks for Prize delivery.

8. Taxes. All federal, state, and local taxes and other tax obligations are the responsibility of the winner, or his/her parent/legal guardian if he/she is a minor, as applicable. Winner should consult with their tax advisor for any tax obligations associated with the Prize.

9. Conditions. By participating, each entrant and winner agrees to release, indemnify and hold harmless Sponsor and its affiliates, partners and promotion and advertising agencies and each of their respective parent companies, subsidiaries, affiliates, partners, representatives, agents, successors, assigns, employees, officers and directors, from any and all liability, for loss, harm, damage, injury, cost or expense whatsoever, including without limitation property damage, personal injury, damage and/or death that may occur, directly or indirectly, whether caused by negligence or not, which may occur in connection with participation in this Sweepstakes, or possession, acceptance and/or use or misuse of Prize or participation in any Sweepstakes-related activity and for any claims based on copyright, trademark, false endorsement, publicity rights, defamation or invasion of privacy and merchandise delivery. Each winner hereby acknowledges that Released Entities have neither made nor are in any



manner responsible or liable for any warranty, representation or guarantee, express or implied, in fact or in law, relative to any Prize. Sponsor is not responsible if Sweepstakes cannot take place or if any Prize cannot be awarded, due to cancellations, delays or interruptions due to acts of God, acts of war, natural disasters, weather, acts of terrorism or any other cause outside of Sponsor's reasonable control. A purchase does not increase odds of winning.

10. Use of Entrants' and Winners' Names; Limitation of Liability. Each entrant and winner agrees that (except where prohibited) Sponsor may use his or her name, Facebook ID, picture (including Facebook profile picture or other additional social media venues), portrait, likeness, address (city and state), biographical information, statements, Submissions and voice in any and all media now known or hereafter developed, throughout the world, in perpetuity for advertising and promotional purposes without further notice or compensation. Sponsor, its promotional and advertising agencies, and all of their respective officers, directors, employees, representatives, and agents shall have no liability and shall be held harmless by winner for any damage, loss, liability or injury to person or property, due in whole or part, directly or indirectly, by reason of the acceptance, possession, use or misuse of Prize or participation in this Sweepstakes or any Sweepstakes-related activity and for any claims based on publicity rights, defamation, invasions of privacy, and merchandise delivery. ANY AND ALL DISPUTES, CLAIMS AND CAUSES OF ACTION ARISING OUT OF OR CONNECTED WITH THIS SWEEPSTAKES, OR ANY PRIZES AWARDED, SHALL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION, AND EXCLUSIVELY BY ARBITRATION. ANY AND ALL CLAIMS, JUDGMENTS AND AWARDS SHALL BE LIMITED TO ACTUAL OUT-OF-POCKET COSTS INCURRED, INCLUDING COSTS ASSOCIATED WITH ENTERING THIS SWEEPSTAKES, BUT IN NO EVENT ATTORNEYS' FEES. Any such controversy or claim shall be arbitrated on an individual basis, and shall not be consolidated in any arbitration with any claim or controversy of any other party. The arbitration shall be conducted in the State of Washington, City of Spokane. THESE OFFICIAL RULES AND THE INTERPRETATION OF ITS TERMS SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF WASHINGTON WITHOUT REGARD TO ITS CONFLICTS OF LAWS RULES. For any matters which are not subject to arbitration as set forth in these Official Rules and/or in connection with the entering of any judgment on an arbitration award in connection with these Official Rules and/or the Sweepstakes, the parties irrevocably submit and consent to the exclusive jurisdiction and venue of the state and federal courts located in or closest to the County of Spokane in the State of Washington. The parties agree not to raise the defense of forum non conveniens.

Sponsor reserves the right, in its sole discretion, to cancel, modify or suspend part or all of this Sweepstakes should virus, bugs, non-authorized human intervention or other causes beyond the control of Sponsor corrupt or impair the administration, security, fairness or proper play of the Sweepstakes. Sponsor and its promotion and advertising agencies are not responsible for technical, hardware, software, telephone or other communications malfunctions, errors or failures of any kind, lost or unavailable network connections, Website, Internet or ISP unavailability, unauthorized human intervention, fraud, incomplete, garbled, inaccurate, or delayed computer transmissions or capture of entry information, whether caused by Sponsor, entrants or by any of the equipment or programming associated with or utilized in this Sweepstakes or by any technical or human error which may occur in the processing of Submissions which may damage an entrant's computer or system or limit an entrant's ability to
